CENTRAL TERMINAL RESTORATION CORP. GROWS BOARD AS NEW FUTURE IS AROUND THE CORNER FOR THE BUFFALO CENTRAL TERMINAL

BUFFALO, NY — The Central Terminal Restoration Corp (CTRC) welcomes Paul V. Harris, PMP, Kimberley LaVare, PMP, Christina P. Orsi, and Rishawn T. Sonubi, AIA to the Board of Directors. The not-for-profit board is overseeing the rehabilitation and reuse of the Buffalo Central Terminal – a majestic historic landmark - as a lasting cultural and economic hub for the community.

Harris, LaVare, Orsi, and Sonubi join the board at a pivotal point in time for the organization and the reuse of the historic Buffalo Central Terminal. This year the organization began Phase 2 of construction to address the highest priority safety and stabilization issues, reopen the Passenger Concourse for public access on a limited basis, and expand use of the Plaza and the Great Lawn. The CTRC will also select a real estate development partner after a year-long, two-stage selection process. The CTRC and real estate developer will work together to push forward the reuse of the Buffalo Central Terminal as a vibrant, hub of activity for the community—a beacon that attracts people and investment.

Paul V. Harris, PMP is a dedicated executive with over 15 years of experience in applied mechanical engineering. Harris currently serves as the Superintendent of Mechanical Maintenance with the Buffalo Sewer Authority, overseeing the second largest wastewater treatment plant in New York State. In this role he provides leadership in strategic goal setting and visioning, operational and organizational culture change within a union environment, as well as high standards of



accountability in service of public health and environmental stewardship. Harris holds a degree in Mechanical Engineering from the University at Buffalo and is a certified Project Management Professional (PMP). Deeply embedded in the Broadway-Fillmore community, Harris serves on the Board of Directors of Broadway-Fillmore Neighborhood Housing Services and the Jericho Road Community Health Center.



Kimberley LaVare, PMP is a certified Project Management Professional (PMP) and currently serves as the Managing Director of the Clementine Gold Group. LaVare holds a Masters of Urban Planning (MUP) from the University at Buffalo. LaVare is a seasoned Diversity Equity and Inclusion (DEI) practitioner with extensive experience in project management, community engagement, construction management, and operations.

She excels at change management and delivering measurable results. Recently, Kim helped clients grow their inclusive procurement by 330% and increase hiring diversity by 50% through operationalizing organizational goals. Her focus has been on community growth and transforming the region by capitalizing on its rich assets.
